

SUSTAINABLE DEVELOPMENT PROJECTS IN **UMNUGOVI PROVINCE**



Oyu Tolgoi invested US\$4.9 million in sustainable, long-term projects in 2022.


WATER USE EFFICIENCY

(2010 - Q3, 2022, in US\$ millions)




Since 2010, Oyu Tolgoi has paid US\$3.81 billion or MNT8.6 trillion in taxes, fees and other payments, including the VAT paid to Mongolian suppliers. In the first three quarter of 2022, Oyu Tolgoi paid US\$237 million or MNT716.8 billion in the form of taxes, fees and other payments to the Government of Mongolia.

TOTAL IN-COUNTRY SPEND

(2010 - Q3, 2022)

Since 2010, Oyu Tolgoi has spent US\$14.5 billion or MNT32.5 trillion in-country in the form of salaries, payments to Mongolian suppliers, taxes and other payments to the Government of Mongolia.




NATIONAL PROCUREMENT

Oyu Tolgoi operations procurement team collaborated with 788 suppliers in 2022, of which 525 are national businesses representing 75% of total operations procurement spend. Since 2010, Oyu Tolgoi has spent US\$4.72 billion on national procurement.


LOCAL PROCUREMENT (UMNUGOVI PROVINCE)

PRODUCTION OF COPPER IN CONCENTRATE


('000 tonnes)



Copper production in concentrate was 36,280 tonnes in the third quarter of 2022. Currently on track to achieve the 2022 copper production guidance range of 110-150 thousand in concentrate.

Gold production in concentrate was 42,716 ounces in the third quarter of 2022. Turquoise Hill Resources revised 2022 gold production guidance from a range of 150,000-170,000 ounces to 165,000-185,000 ounces.

In third quarter of 2022, the Underground development at Oyu Tolgoi continued to progress with the lateral development advancing by 4,227 metres.
